## SESIP 2020 Pricelist v2.1

Below are the standard prices for typical certification projects running with a fully licensed evaluator for SESIP certifications against GlobalPlatform SESIP v1.0 under TrustCB Scheme Procedures for SESIP v2.1.

A-typical projects are estimated up-front on a case-by-case basis.

The above prices assume the meetings between the certifier and the evaluator (and optionally the Sponsor) will be held remotely. If the Sponsor wishes those **meetings to be held in-person** an **additional €1.500 per meeting** will be added to the certification price.

Typical costs of additional certification activities:

Additional evaluation meeting (required if earlier evaluation meeting led to fail conclusion)	1 in-person meeting	€ 7.500
Additional extended <sup>1</sup> evaluation meeting (required if earlier meeting led to fail conclusion, with serious issues in evaluation activities performed indicating the project has gone outside of the optimized path)	1 in-person meeting	€ 10.000

All prices are excluding VAT and subject to the TrustCB general conditions.

<sup>1</sup> If an extra meeting is needed, the project has gone outside of the optimized path hence it will be an *extended* meeting.
